Terms of Service	
1	CYNET provides the Subscriber the service that is described in the above table with the following terms and conditions.
2	This contract is automatically renewed for 12 months, unless one of the two parties request for disconnection and officially informs the other party 30 days prior.
3	The subscriber has to pay, in addition to the fees and other expenses presented in the table above, the VAT Tax calculated according to the law as well as any other indirect tax that may be imposed in the future.
4	The subscriber is obliged to pay off every invoice before the time indicated to him. Invoices not paid in full before or at the expiry time shall be credited with an interest rate.
5	The subscriber must use the service for his own organization only.
6	The parts should recognize that the service is provided in the situation as is and that possible interruptions and degradation or service of quality might occur in result of electrical or mechanical unforeseen damages or other causes. In such a case the responsibility of CYNET is limited in the good faith effort of re-establishment of service with each reasonable speed.
7	CYNET will inform the subscriber at least one (1) month before regarding any changes at the fees of the service or in the terms of the contract in regard to the proposed modification.
8	The subscriber is eligible to terminate the service without sanctions if he does not accept the notified modification of fees or new terms of service.
9	Each notification and communication that concerns the present contract and the parts involved, has to be in writing and addressed to all parts in the addresses shown in the contracts, unless a change of address has been previously been approved in writing from every member.
